Hong Kong Link Limited started in 2003 as a manufacturer and trader of jewellery and fashion jewellery based in Hong Kong.

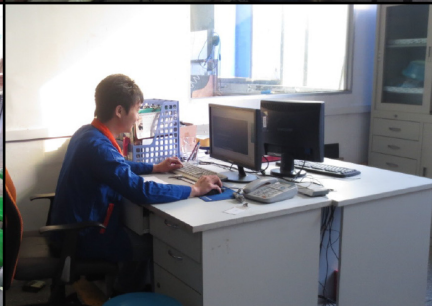
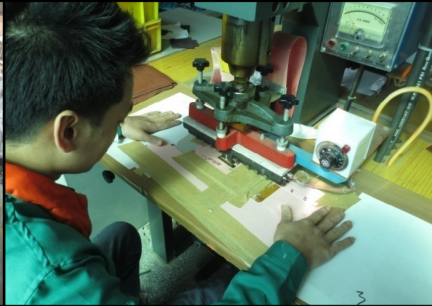
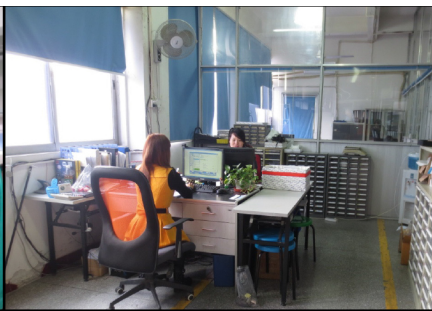
In 2006, with the creation of our production plant in mainland China (Shuang Li), Hong Kong Link Limited became our trading arm, serving both export and domestic sales.

In 2006 we founded our direct production site in Chang An (Dongguan) in the Guangzhou Province.

The Manufacturing business is fully registered as China Domestic Company with Import and Export License and named **Shuang Li** Jewellery and Leather Company (in 2008 changed to Limited Company).

The main production plant was created on a **surface of 1500 sqm.** with a workforce of 80 workers **devoted to produce all kind of Jewellery** and imitation jewellery by using following major metals: **Silver, Stainless Steel, Alloy.**

The Company grew a leading reputation, being able to create and combine alternative materials to the basic metals: in particular Genuine Leather and Rubber, all imported from Italy.

In 2009 our Company diversified and expanded the business into **leather accessories** by creating a Leather Accessories Production Department within our production plant area.

In 2010 we enlarged our Production Plant by adding an extra 1500 sqm. and two warehouses, to reach **an overall area of 3000 sqm.**

With a **centralized management** and two independent Production Department, we have been specializing more and more in order to serve a highly demanding clientele in the fashion industry.

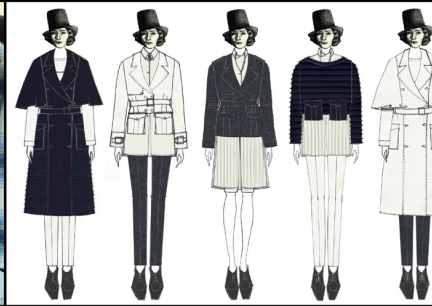
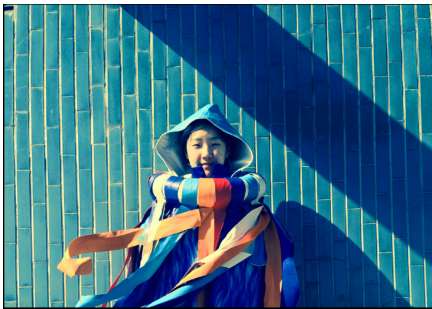

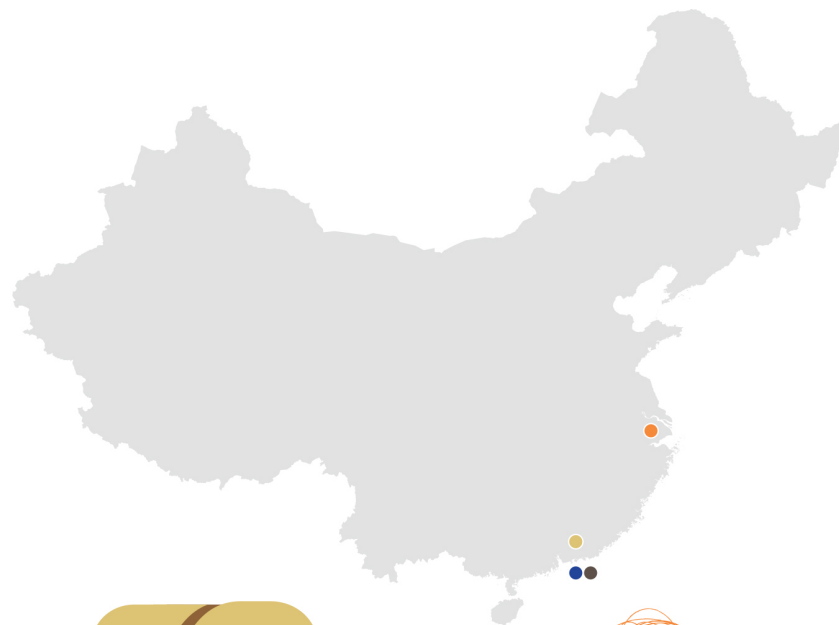
